Tenders in plain paper in sealed covers are invited by the undersigned for disposal of Ambassador Diesel Car of Home Department bearing Registration No. OR-02-R-7007.

2. The intending tenderers are advised to inspect the vehicle parked in M/s Harinandan Motor Works, Plot No. 667, Old Station Square, Cuttack Road, Bhubaneswar between 11.00 A.M. to 3.00 P.M., seven days before submitting tender. The tender should accompany earnest money deposit of Rs. 1000/- (Rupees One Thousand) only in shape of Bank Draft in favour of D.D.O.-cum-Under Secretary to Government, Home Department payable at UCO Bank, Odisha Secretariat Branch, Bhubaneswar which will be refunded to the tenderers whose tenders are not accepted except in case of the successful bidder.


3. The tender/bid should reach the undersigned by 29.12.2016 up to 3.00 P.M. at the latest and tenders received shall be opened by Under Secretary to Government, Home (OE-II) Department at 4.00 P.M. on 29.12.2016 in the presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time.

4. The highest tenderer/bidder whose tender will be accepted shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited.

VAT as admissible shall be levied on the bidding cost.

5. The successful bidder shall take permission and remove the vehicle from M/s Harinandan Motor Works, Plot No. 667, Old Station Square, Cuttack Road, Bhubaneswar within two days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent@ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid site. If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the vehicle & the amount deposited by him shall be adjusted towards ground rent.

6. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
