The tender/bid should reach the undersigned by 31.08.2016 up to 3.00 P.M. at the latest and tenders received shall be opened by Under Secretary to Government, Home (OE-II) Department at 4.00 P.M. on 31.08.2016 in the presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time.
- 4. The highest tenderer/bidder whose tender will be accepted shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited.
