Applications in plain paper are invited from the intending Suppliers/Firms/Co-operative Societies/Contractors/Corporation who are registered dealers under GST Act for registration of their names as approved suppliers for supply of Principal Food Grains and other Misc. Articles including Vegetables, Chicken, Eggs, Milk, Paneer etc. as per approved schedule of articles to Spl. Jail, Bhubaneswar during the year 2019-2020 to be received by **the Superintendent of Spl. Jail, Bhubaneswar up to 05.00 P.M. of 16.09.2019.**


The applicants should state in their applications, their financial capacity and past experience, if any, for consideration of their cases for registration as approved suppliers. The documents in support of financial capacity will mean solvency certificate (up-to-date) issued by a competent Revenue Officer not below the rank of Tahsildar for `3, 00,000.00 (Rupees Three Lakh) only for Bhubaneswar Spl. Jail. The Xerox copies of the documents duly attested by the bidder in support of their financial capacity and past experiences together with a Copy of PAN Card up-to-date GST Certificate should accompany with their applications for registration of their names in the Jail Office as approved supplier. The applicant having required solvency Certificate should be allowed to supply materials to Special Jail, Bhubaneswar only for applying to supply dietary & Misc. article to each jail, the applicant has to submit the required Solvency Certificate up to the limit specified above separately. Acknowledgement of application along with all the documents should be obtained from the Superintendent, Spl. Jail, Bhubaneswar. On the date of registration, the original certificate of the above documents should be produced before the Superintendent of Bhubaneswar Jail for registering their names as approved supplier. No application for registration will be entertained by the undersigned, if it is not received within the stipulated time. The registered supplier of this Jail will be eligible to **submit the tender for Special Jail, Bhubaneswar only.**

Prior to submission of tender, the suppliers are required to obtain all other information concerning to the terms and conditions of contract and details of probable requirement of articles from the Superintendent of Special Jail Bhubaneswar. As the Jail population fluctuates from time to time, exact requirement cannot be indicated specifically at this stage.

The approximate quantity of supplies of principal food grains and other misc. articles for the year 2019-2020 in respect of Spl. Jail, Bhubaneswar are titled as "**Approved schedule of Articles for Special Jail, Bhubaneswar**" and available with the Superintendent of Bhubaneswar Jail. The articles are required to be delivered at the Jail Gate of Bhubaneswar at the tendered rate.

The competent authority i.e. Addl. Director General of Police cum-Inspector General of Prisons and Director Correctional Services, Odisha, Bhubaneswar reserves the right in the public interest, to reject any tender and may order the under signed to purchase articles from the open market, if rates, terms and conditions of the tender are not agreeable.

After registration of their name with the under signed, sealed tender quoting rates etc. to be submitted directly to the **Superintendent of Spl. Jail, Bhubaneswar on or before 05.00 P.M. of 21.09.2019.** Sealed tenders will be opened at **03.00 P.M. on 23.09.2019** or in consultation with the Chairman of the Purchase Committee.
