In exercise of the powers conferred by Sub-Section (1) of Section 11 of the Code of Criminal Procedure, 1973 (Act-II of 1974) and all other powers under the said Act enabling the State Government in this regard and on the recommendations of and in consultation with the High Court of Orissa, the State Government, do hereby establish courts of Judicial Magistrate of the First Class in each Revenue District Head Quarters of the state to try cases relating to offences against women with local limits of jurisdiction as mentioned against each of them in the schedule given below.
