OFFICE ORDER

Bhubaneswar dated the 16.09.2024

No. HOME-CC-APMT1-0001-2020 32940 /CC. Sri Ajaya Kumar Padhi (UR), selected by Odisha Staff Selection Commission bearing serial No. 80 vide their Notification No. IIE-159/2015/33/OSSC; dated 07.01.2021 is hereby appointed as Junior Data Entry Operator in Parliamentary Affairs Department against one vacant post of Junior Data Entry Operator transferred from H & UD Department and allotted to Parliamentary Affairs Department vide Home Department Notification No. 32937, dated 16.09.2024 for deployment to Hon'ble Governor's Secretariat on a contractual basis with consolidated remuneration of Rs.8880/- in stage-4 of the Fitment Table of Odisha Group-C and Group-D posts of the (Contractual Appointment) Amendment Rules, 2017 vide Notification No. 19574, dated 12.09.2017 of GA & PG Department.

He will remain in contractual engagement for six years from the date of his joining into the service as per the provisions of the said rules.

1. The appointment is purely temporary and terminable at any time without prior notice and assigning any reason thereof.
2. He should join in the Department allotted within 30 (Thirty) days from the date of issue of this order, failing which his appointment order shall be deemed cancelled.
3. He is directed to furnish the following documents in original to the concerned Administrative Department together with a self-attested xerox copy of them at the time of joining for verification by the Administrative Department. In case of failure to produce the documents, the joining shall not be accepted by the Administrative Department.
 - (i) Original Certificates in support of Educational Qualifications.
 - (ii) Two self-attested passport-size photographs.
 - (iii) Medical Fitness Certificate from concerned CDMOs/Public Health Officers.
 - (iv) Two character certificates from two respectable persons of the locality which include the local public representatives in the enclosed format.
 - (v) A declaration to the effect that no criminal antecedent/case is pending against him/her in an enclosed format.
 - (vi) Oath of allegiance to the Constitution of India in the enclosed format.
 - (vii) Declaration of non-contact of plural marriage in the enclosed format.
 - (viii) Caste Certificate (if the candidate belongs to ST/SC/SEBC).
 - (ix) Certificate for Persons with Disability (as applicable).
