Sub:- Fixation of criteria for appointment to the post of Chief Fire Officer, Fire Prevention Wing (Superior Administrative Grade).

The question of fixation of criteria for appointment to the newly created post of Chief Fire Officer, Fire Prevention Wing (Superior Administrative Grade) in Odisha Fire Service was under active consideration for some time past. After careful consideration, Government have been pleased to decide that appointment to the post of Chief Fire Officer, Fire Prevention Wing (Superior Administrative Grade) shall be made in the following manner till finalization of the "Odisha Fire Service (Conditions of Service & Method of Recruitment of Group-A & B Officers) Rules proposed to be framed under Section 26 of the Orissa Fire Service Act, 1993.

- I. The post of Chief Fire Officer, Fire Prevention Wing (Superior Administrative Grade) shall be filled up by way of promotion from the rank of Chief Fire Officer (Super Time Scale) on the basis of merit and suitability with due regard to seniority.
- II. The provision of the Odisha Civil Services (Criteria for promotion) Rules, 1992 and the Odisha Civil Services (Zone of consideration for promotion) Rules-1988 and subsequent amendment made to it shall be followed.
- III. There shall be constituted a Departmental Promotion Committee for considering promotion to the rank of Chief Fire Officer, Fire Prevention Wing (Superior Administrative Grade) from the rank of Chief Fire Officer (Super Time Scale) with the following members.
 1. Chief Secretary, Odisha -Chairperson
 2. Secretary to Government,
Home Department -Member
 3. Director General, Fire Service, Odisha, Cuttack -Member
 4. Deputy Secretary/Joint Secretary/Addl. Secretary
In-charge of Fire Service Section -Member Convener
- IV. The instruction contained in General Administration Department Office Memorandum No.3928 dated 18.02.1994 and subsequent amendment made to it shall be applicable in the matter of promotion to the post of Chief Fire Officer, Fire Prevention Wing (Superior Administrative Grade).

- V. The recommendation of the DPC shall be valid and can be operated upon notwithstanding the absence of anyone of its members other than Chairperson.

Provided that the member so absenting was duly invited to attend the meeting of the committee and the majority of members of the committee attended the meeting.

- VI. This Resolution shall come into force from the date of issue.

ORDER:- Ordered that the Resolution be published in an extraordinary issue of the Odisha Gazette and copies thereof be forwarded to all Departments of Government /All Heads of Departments/All Collectors/Special Secretary, Odisha Public Service Commission, Cuttack/Registrar, Odisha High Court, Cuttack.
