The Fire Station sanctioned for Rairangpur in Mayurbhanja District vide this Department Letter No.103/P, dated 03.01.1972 is functioning under Bijatola block of the District. Subsequently, another Fire Station has been sanctioned at Rairangpur naming as Rairangpur-II Fire Station under Bijatola block of the said District vide this Department Notification No.1243/CD, dated 27.09.2013, as per the proposal of the Directorate of Fire Service.

Now, the Directorate of Fire Service have proposed for changing of name of Rairangpur Fire Station and Rairangpur-II Fire Station as Bijatola Fire Station and Rairangpur Fire Station under Bijatola block and Rairangpur block respectively, as Rairangpur block is remaining uncovered due to functioning of the Rairangpur Fire Station sanctioned earlier in the Bijatola block.

After careful consideration of the proposal, the State Government have been pleased to decide to change the name of the said two Fire Stations as follows, in partial modification of the afore-said letter and Notification of this Department.
