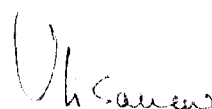
A Fire Station was sanctioned at Gopalpur under Rangeilunda Block in Ganjam District vide this Department Notification No.897/CD, dated 29.06.2011. Subsequently, permission was accorded by this Department for construction of Gopalpur Fire Station building at Kanishi instead of Gopalpur vide this Department Letter No.1216/CD, dated 19.10.2012, as per proposal of Directorate of Fire Service. Accordingly, Gopalpur Fire Station building has been constructed at Kanishi and the said Fire Station has been functioning at Kanishi.

Now, the Directorate of Fire Service have proposed to change name of Gopalpur Fire Station to Kanishi Fire Station under Rangeilunda Block of Ganjam District to avoid confusion, as the said Fire Station is functioning at Kanishi.

After careful consideration of the proposal, the State Government have been pleased to decide to change the name of Gopalpur Fire Station to Kanishi Fire Station under Rangeilunda Block of Ganjam District, in partial modification of the afore-said Notification of this Department.

The said Kanishi Fire Station may also be counted against Rangeilunda Block under the one Fire Station per Block rule.

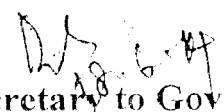

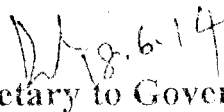

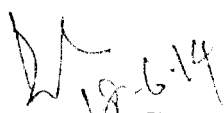
