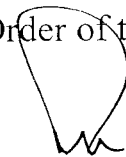
In order to provide time bound service to stakeholders and to maintain transparency and accountability on the part of the officials, the workflow process of the following services shall be dealt with online web-systems only, and any functions with offline mode is dispensed forthwith:

- NOC required for setting up of explosives manufacturing, storage, sale, transport.
- NOC required for setting up of petroleum, diesel & Naptha storage, sale, transport.
- License for sale of crackers(permanent and temporary)
- Approvals for setting up of hostels.

The Certificates downloaded from the online portal in this respect will be valid across the State.

2. No physical/ manual application shall be required to be submitted to the authorities in addition to online application.
3. No physical copies of documents shall be required by the authority which was uploaded by the applicant at the time of submission of online application.
4. The application shall be disposed off within the stipulated timeline.
5. Authorities shall accept downloaded digitally signed certificates from the portal as valid and shall not require physically signed/stamped certificate. However, the applicant shall produce authentic copy of the respective documents on demand by the appropriate authority during inspection/site visit.
6. The applicant shall not be required to get in touch with authorities physically except in cases where inspection/site visit is mandated by law.
