Consequent upon promotion to the rank of Assistant Fire Officer vide Home Department Notification No.723/CD dated 08.08.2014, Shri Kailash Chandra Mallick assumed the higher charge of Assistant Fire Officer, Boudh Fire Stations w.e.f. 26.08.2014 A.M. He has exercised option for fixation of his pay on accrual of his next increment in the lower rank w.e.f. 01.10.2014 under Rule-13 (2) of ORSP Rules, 2008. Prior to promotion, he was drawing pay of Rs.14,350/- + GP Rs.4200/- in Pay Band Rs.9300-34,800/- w.e.f. 01.10.2013.

On promotion to the rank of Assistant Fire Officer, the pay of Shri Mallick is fixed at Rs.14,350/- + G.P. Rs.4600/- in the Pay Band Rs.9300-34,800/- w.e.f. 26.08.2014 under Rule 13(2) of ORSP Rule, 2008.

The pay of Shri Mallick is re-fixed at Rs.15,490/- + G.P. Rs.4600/- per month in the pay band Rs.9300-34,800/- + GP Rs.4600/- w.e.f. 01.10.2014 under Rule 13 (2) of ORSP Rules, 2008.

His date of next increment will fall due on 01.10.2015 under normal circumstances.
