Consequent upon promotion to the rank of Assistant Fire Officer vide Home Department Notification No.723/CD dated 08.08.2014, Shri Sarbeswar Baral assumed the higher charge of Assistant Fire Officer, Baripada Fire Stations w.e.f. 25.08.2014 A.M. He has exercised option for fixation of his pay on accrual of his next increment in the lower rank w.e.f. 01.02.2015 under Rule-13 (2) of ORSP Rules, 2008. Prior to promotion, he was drawing pay of Rs.13,410/- + GP Rs.4200/- in Pay Band Rs.9300-34,800/- w.e.f. 01.02.2014.

On promotion to the rank of Assistant Fire Officer, the pay of Shri Baral is fixed at Rs.13,410/- + G.P. Rs.4600/- in the Pay Band Rs.9300-34,800/- w.e.f. 25.08.2014 under Rule 13(2) of ORSP Rule, 2008.

The pay of Shri Baral is re-fixed at Rs.14,490/- + G.P. Rs.4600/- per month in the pay band Rs.9300-34,800/- + GP Rs.4600/- w.e.f. 01.02.2015 under Rule 13 (2) of ORSP Rules, 2008.

His date of next increment will fall due on 01.02.2016 under normal circumstances.
