Consequent upon promotion from the rank of Fire Officer to the rank of Chief Fire Officer of Odisha Fire Service Sri Maheswar Swain assumed the charge of Director, OFDRA-Cum-Chief Fire Officer, Fire Prevention Wing, Cuttack on 20.05.2019 F.N. vide Home Department Notification No.19815/CD, dated 16.05.2019.

He has exercised his option to get his pay fixed on 01.07.2019 after accrual of increment in the pre-promotional post i.e. Fire Officer.

Prior to promotion he was drawing Pay of Rs.80,900/- in Cell-7, Level-13 of Pay Matrix w.e.f. 01.07.2018.

On promotion to the rank of Chief Fire Officer his Pay is fixed @ Rs.78,800/- +R.P.P.-Rs.2100/- in Cell-1, Level-14 of Pay Matrix w.e.f. 20.05.2019 under Rule 12(ii) of ORSP Rules, 2017.

He is allowed to get one increment on 01.07.2019 in pre-promotional post and his pay is raised from Rs.80,900/- to Rs.83,300/- in Cell-8, Level-13 of Pay Matrix. After adding one increment his pay is raised to Rs.85,800/- in Cell-9, Level-13 of Pay Matrix.

Accordingly, his pay is re-fixed @ Rs.86,100/- in Cell-4, Level-14 of Pay Matrix w.e.f. 01.07.2019 under Rule 12(ii) of ORSP Rules, 2017 against the promotional post of Chief Fire Officer.

His date of next annual increment shall fall due on 01.07.2020 under normal circumstances.

He is also allowed to draw D.A. and other allowances as admissible under rules from time to time.

This has been concurred in by Home (Finance Section) Department vide their U.O.R. No.327/FS-1, dated 20.07.2019.
