Consequent upon promotion from the rank of Station Officer to the rank of Assistant Fire Officer of Odisha Fire Service Sri Ramesh Chandra Mohanty assumed the charge of Assistant Fire Officer on 31.07.2019 F.N. vide Home Department Notification No.26030/CD, dated 03.07.2019.

He has exercised his option to get his pay fixed on 01.12.2019 after accrual of increment in the pre-promotional post i.e. Station Officer.

Prior to promotion he was drawing Pay of Rs.44,900/- in Cell-9, Level-9 of Pay Matrix w.e.f. 01.12.2018.

On promotion to the rank of Assistant Fire Officer his Pay is fixed @ Rs.44,900/- in Cell-1, Level-10 of Pay Matrix w.e.f. 31.07.2019 under Rule 12(ii) of ORSP Rules, 2017.

As per his option, he is allowed to draw his annual increment w.e.f. 01.12.2019 in his pre-promotional post raising his pay from Rs.44,900/- to Rs.46,200/-.

Thereafter, the pay of Sri Mohanty, Assistant Fire Officer is re-fixed at Rs.47,600/- in Cell-3 of Level-10 of Pay Matrix w.e.f. 01.12.2019 under Rule 12(ii) of ORSP Rules, 2017.

His date of next annual increment shall fall due on 01.12.2020 under normal circumstances.

He is also allowed to draw D.A. and other allowances as admissible from time to time under rules.

This has been concurred in by Home (Finance Section) Department vide their U.O.R. No. 75 /FS-1, dated. 19.06.2020.
