“Shri Kartikeswar Samal, OPS-1, Superintendent of Police, SIW is transferred and posted as Superintendent of Police, Special Branch.”

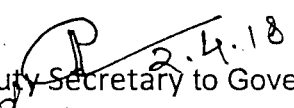
(2) All other terms and conditions contained in 2<sup>nd</sup> para of the aforesaid Notification are deleted.

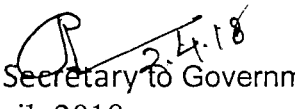

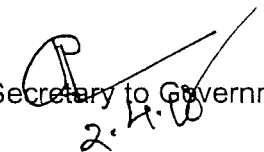
