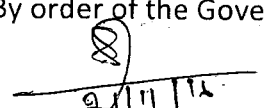
Bhubaneswar dated the 21st November, 2016.

On promotion, they are posted as Under Secretary in the Departments as mentioned against each as per the following.

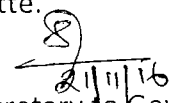

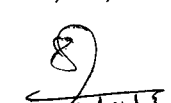
