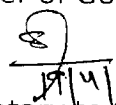

On promotion, they are posted as Desk Officer in the Departments as mentioned against their names in the table below.

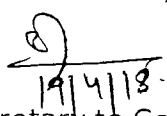

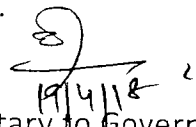
