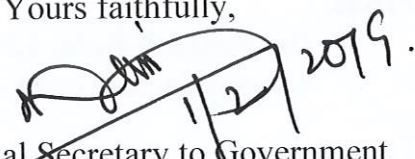
(2) The newly created base level Group – B & Group- C posts meant for direct recruitment shall be filled up on contractual basis as per the stipulations contained in the erstwhile G.A Department Notification No. 32010/ Gen. dated 12.11.2013 read with Notification No. 19574/Gen. dated 12-09-2017 and Notification No. 1147/Gen. dated 17-01-2014 read with Notification No. 19569/Gen. dated 12-09-2017 after following relevant recruitment rules and provisions of ORV Act.

Their service conditions and emoluments shall be governed by as per the above Notifications of the erstwhile G.A. Department. The promotional posts, if any, may be filled up observing relevant Rules and ORV Act.

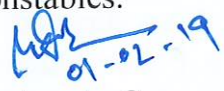

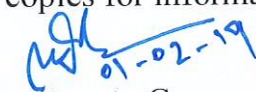
