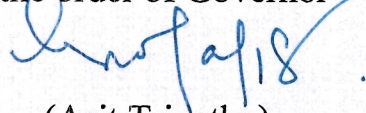
NOTIFICATION

No.HOME-DA1-LAND-0001-2016/41094 /D&A, In supersession of all earlier orders and notifications of this Department on organization / re-organization of Railway Police Districts in the State, the State Government have been pleased to re-organise the Railway Police districts, Cuttack and Rourkela as per the provisions of Rule 1 -A(3) read with Rule 459 of Odisha Police Rules as given below.

- 1) The Railway Police District, Cuttack shall comprise of all areas in respect of existing and upcoming 'Railway Limits' within the Revenue districts of; i) Mayurbhanj, ii) Balasore, iii) Bhadrak, iv) Keonjhar, v) Jajpur, vi) Kendrapara, vii) Cuttack, viii) Jagatsinghpur, ix) Dhenkanal, x) Angul, xi) Khurdha, xii) Puri, xiii) Nayagarh, xiv) Ganjam, xv) Gajapati and xvi) Gunupur Revenue Sub-Division of Rayagada district.
- 2) The Railway Police District, Rourkela shall comprise of all areas in respect of existing and upcoming 'Railway limits', within the the Revenue districts of i). Sundergarh, ii) Jharsuguda, iii) Deogarh, iv) Sambalpur, v) Bargarh, vi) Bolangir, vii) Subarnapur, viii) Boudh, ix) Kandhamal, x) Nuapada, xi) Kalahandi, xii) Nawarangpur, xiii) Malkangiri, xiv) Koraput and xv) Rayagada district excluding Gunupur Revenue Sub-Division.

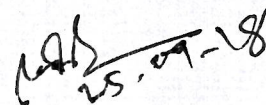
