No. HOME-DA1-CRTN1-0010-2020 40954 /D&A, In exercise of the powers conferred by clause(s) of Section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of all previous notifications so far as it relates to establishment of Bhanjanagar Police Station, Buguda Police Station, J.N. Prasad Police Station, Tarasingi Police Station in Ganjam district, the State Government do hereby declare Belaguntha Outpost in Ganjam district to be a Police Station called **Belaguntha Police Station** which shall include the villages as specified in column (3) in the schedule below and declare that the same shall come into force from the date of publication of this Notification in Odisha Gazette.

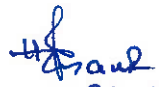
