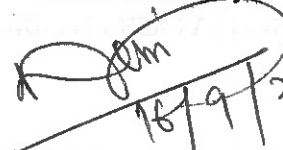
2. The recruitment for the afore-mentioned posts shall be made in a transparent manner following the relevant recruitment rules and provisions of ORV Act. The base-level posts meant for direct recruitment shall be filled up on a contractual basis initially be followed with the relevant recruitment rules and provision of ORV Act as well as the stipulations contained in erstwhile G.A Department Notification No.32010/Gen. dated 12.11.2013 read with Notification No.19574/Gen. dated 12.09.2017 and Notification No.1147/Gen. dated 17.01.2014 read with Notification No. 19569/Gen. dated 12.09.2017. Their service condition and emoluments of posts so created will be governed by the said notification of G.A Department.

The promotional posts, if any, are to be filled up observing relevant Rules and ORV Act.

3. In case, the immigration function are taken over by Bureau of Immigration (BoI), Ministry of Home Affairs, Government of India in future, the posts so sanctioned for Immigration Check Post at Dhamara sea Port, Bhadrak would become redundant and in that eventuality these posts should be brought over to the sanctioned strength of District Police, Bhadrak.
