Sub: Establishment of a Special Crime Unit under Commissionerate Police, Bhubaneswar-Cuttack

Sir,

I am directed to convey the sanction of Governor for creation of 59 posts in various ranks, in the newly created Special Crime Unit under Commissionerate Police, Bhubaneswar-Cuttack established dedicatedly to monitor and analyse the serious / complex crimes occurring within Commissionerate Police limits for their prevention / detection and control, in the level of pay mentioned against each and other allowances as sanctioned by the Government from time to time.

2. These posts are being created in lieu of immediate abolition of 63 number of posts from 2nd OSAP (SS) Battalion, Keonjhar as indicated below.

3. The recruitment to these posts shall be made in a transparent manner following the relevant recruitment Rules and provisions of ORV Act. The base level posts meant for direct recruitment shall be filled up on contractual basis initially following the relevant recruitment rules and provisions of ORV Act as well as stipulations contained in erstwhile GA Department Notification No. 32010/Gen. dated 12-11-2013 read with Notification No. 19574/Gen. 12-09-2017 and Notification No. 1147/Gen. dated 17-01-2014 read with Notification No. 19569/Gen. dated 12-09-2017 and subsequent notifications in this regard. Service conditions and emoluments of posts so created will be governed by the said notification of erstwhile GA Department.

The promotional posts, if any, are to be filled up observing relevant Rules and ORV Act.

4. The newly created Special Crime Unit shall be located in headquarters of Commissionerate Police, Bhubaneswar-Cuttack and comprise of the following wings:

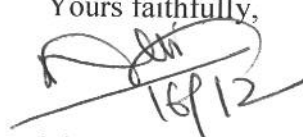
Serial No.	Name of the Wing	Shall deal with
i.	Narcotics	NDPS cases related to drugs and contrabands
ii.	Anti Fraud	Major offenses involving land , real estate, organized frauds like job scams, cyber cheating, chit fund and other high value economic offences
iii.	Organized Crime	Extortion, <i>Dada Batti</i> , major property crime as well as street crime

5. The charge is debitable to the appropriate Units of Administrative Expenditure under Head 'Demand No.1-2055-Police-EOME-001-Direction and Administration-1712-Introduction of Commissionerate system in twin cities of Cuttack and Bhubaneswar.'

6. Further, four vehicles shall be hired for the newly created 'Special Crime Unit' under Commissionerate Police, Bhubaneswar-Cuttack in accordance with Finance Department Office Memorandum No. 34085 dated 29-09-2012 , Office Memorandum No. 30464 dated 06-09-2019 and other relevant Finance Department circulars issued from time to time.

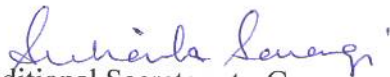

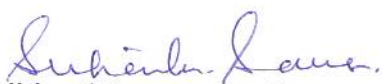
