Sub: Upgradation of three existing Police Outposts under Commissionerate Police, Bhubaneswar-Cuttack to full fledged Police Stations – Creation of posts thereof

Sir,

I am directed to convey the sanction of Governor for upgradation of three Police Outposts under Commissionerate Police, Bhubaneswar-Cuttack mentioned at **Annexure** to that of full fledged Police Stations with creation of 45 additional posts over and above the personnel already available in the said Police Outposts, in the level of pay mentioned against each and other allowances as sanctioned by the Government from time to time.

2. These posts are being created in lieu of immediate abolition of 51 number of posts from 2nd OSAP (SS) Battalion, Keonjhar as indicated below.

3. These 45 posts are created with the stipulation that, the promotional posts should be filled up as per the relevant rule and due procedure.

The base level posts meant for direct recruitment shall be filled up on contractual basis initially following the relevant recruitment rules and provisions of ORV Act as well as stipulations contained in erstwhile GA Department Notification No. 32010/Gen. dated 12-11-2013 read with Notification No. 19574/Gen. 12-09-2017 and Notification No. 1147/Gen. dated 17-01-2014 read with Notification No. 19569/Gen. dated 12-09-2017 and subsequent notifications in this regard. Service conditions and emoluments of posts so created will be governed by the said notification of erstwhile GA Department.

The promotional posts, if any, are to be filled up observing relevant Rules and ORV Act.

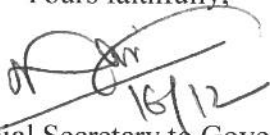
4. The charge is debitable to the appropriate Units of Administrative Expenditure under Head 'Demand No.1-2055-Police-EOME-001-Direction and Administration-1712-Introduction of Commissionerate system in twin cities of Cuttack and Bhubaneswar.'

5. Further, 06 vehicles shall be hired for the said three Police Stations (i.e @ 2 vehicles per Police Station) in accordance with Finance Department Office Memorandum No. 34085 dated 29-09-2012, Office Memorandum No. 30464 dated 06-09-2019 and other relevant Finance Department circulars issued from time to time.

6. This has been concurred in by the Finance Department in their file no. FIN-GS1-CADRE-0023-2017.

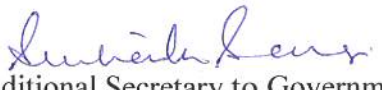

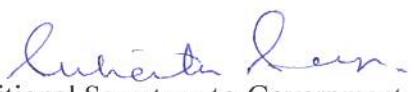
