(2) The newly created base level Group-B and Group-C posts meant for direct recruitment shall be filled-up on contractual basis as per the stipulations contained in GA Department Notification No:-32010/Gen, dt.12.11.2013 and No:-1147/Gen, dt.17.01.2014 after following relevant recruitment Rules and provisions of ORV Act.

Their Service Conditions and emoluments shall be governed by the aforesaid Notification of GA Department. The promotional posts, if any, shall be filled-up by observing relevant Rules and ORV Act.

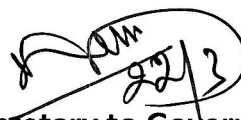

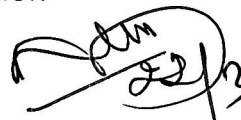

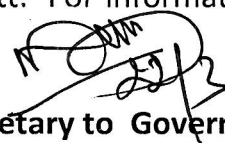
