No. HOME-DA1-CRTN2-0011-2017 - 28195 /D&A, In exercise of the powers conferred by clause(s) of Section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) and in partial modification of all previous notifications so far as it relates to establishment of Khurda Police Station in Khurda district, the State Government do hereby declare Baghamari Beat House in Khurda district to be a Police Station called **Baghamari Police Station** which shall include the villages as specified in column (3) in the schedule below and declare that the same has started functioning since 01-03-2019.

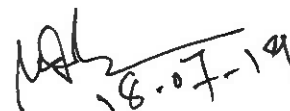

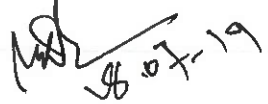

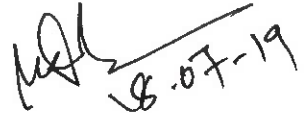
