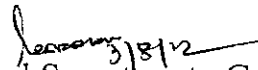

The decision on promotion of Sri Raghunath Majhi(ST), Jailor to the rank of Superintendent of District Jail held in the meeting of the D.P.C. on 28.08.2009 was kept in the sealed cover due to pendency of a disciplinary proceeding. On conclusion of the disciplinary proceeding, Sri Raghunath Majhi, Jailor, is promoted to the rank of Superintendent of District jail (Group-B) in the scale of pay of Rs.9,300-34,800/- with Grade Pay of Rs.4,600/- on adhoc basis for a period of one year or till receipt of concurrence of the Odisha Public Service Commission, whichever is earlier.

The promotion shall be given effect from 23.11.2009 notionally with the actual financial benefit from the date of joining in the promotional post as per the instructions contained in General Administration Department Office Memorandum No.29600-SC-3-5/97-Gen dt.01.11.1997.

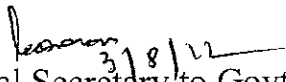
On promotion, Sri Majhi is posted as Superintendent, District Jail, Bolangir against the existing vacancy.
