(HOME-CC-RULE-0001-2014)

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha hereby makes the following rules further to amend the Odisha Secretariat Service(Method of Recruitment and Conditions of Service of Assistant Section Officers) Rules, 2010, namely:-

1. (1) These rules may be called the Odisha Secretariat Service (Method of Recruitment and Conditions of Service of Assistant Section Officers) Amendment Rules, 2014.
(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha Secretariat Service (Method of Recruitment and Conditions of Service of Assistant Section Officers) Rules, 2010 (hereinafter referred to as the said rules), in rule 5, clause (c) shall be omitted.
3. In the said rules, Part-V shall be omitted.
4. In the said rules, in rule 16, in sub- rule (1), the symbol and the figure “& 15” shall be omitted.
5. In the said rules, in rule 17, in sub-rule (2), the words “to those appointed by limited departmental examination under clause (c) of Rule-5, who shall in turn enbloc be senior” shall be omitted.




