The Selection Committee Meeting held on 29.06.2019 could not assess the suitability of Sri Tarun Ch. Madhei (ST) due to inadequate CCRs/PARs as required under GA Department Notification No. 5906/2RT/1-24/2004/Gen, dated 25.02.2005 and defer his case.

But, inadvertently the name of Sri Tarun Ch. Madhei (ST) whose name was in the deferred list was placed in the promotion Notification No. 25696/OSS, dated 29.06.2019 for promotion of Desk Officers to the rank of Under Secretary instead of Sri Bimbardhar Pradhan (ST) from the said select list.

And consequent upon such reversion of Sri Tarun Ch. Madhei (ST), Sri Bimbardhar Pradhan (ST), Desk Officer, Works Department whose Sl. No.186 in the said select list is promoted as Under Secretary in Home Department retrospectively w.e.f. 29.06.2019.
