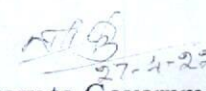
2. On return from Maternity Leave, Smt. Jasmita Meher, ASO of this Department is allowed to work in B & P Section of this Department as earlier.

4. Miss Truptimayee Pradhan, Section Officer, M & D Section is transferred from M & D Section and posted as such in Pension Section of this Department.

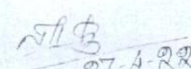
