Sub: Bifurcation of existing Bhadrak Police Sub-Division in Bhadrak district into (1) Bhadrak City Police Sub-Division and (2) Bhadrak Sadar Police Sub-Division – creation of posts thereof.

Sir,

I am directed to convey the sanction of Governor for bifurcation of existing Bhadrak Police Sub-Division in Bhadrak district into (1) Bhadrak City Police Sub-Division and; (2) Bhadrak Sadar Police Division along with creation of 4 (four) posts in different categories of posts in the level of pay mentioned against each and other allowances sanctioned by Government from time to time.

2. The afore-mentioned four posts are being created in lieu of immediate abolition of equal number of posts in the same scale of pay from Police Motor Transport (PMT), Odisha, Cuttack and Dhenkanal Police District as indicated below.

3. The afore-mentioned newly created posts are to be filled up in a transparent manner following the relevant recruitment rules and provisions of ORV Act.



The promotional posts are to be filled up observing relevant Rules and ORV Act.


