Sub: Revision of rate of honorarium for Guest Faculties in Biju Patanik State Police Academy, Bhubaneswar

Ref: Proposal of State Police Headquarters furnished in their file DP-ACCT-MISC-0002-2022

Sir,

Inviting reference to the subject cited above and in supersession of this Department's earlier letter no. 45050/D&A dated 22-11-2017; I am directed to convey the approval of Government for revision of rate of honorarium for Guest Faculties in Biju Patanik State Police Academy (BPSPA), Bhubaneswar as follows:

1. The rate of honorarium for Guest lecturers per session of 60 minutes/ 75 minutes in respect of Government officers shall be Rs. 1000/- per session and for non-Government Officers shall be Rs. 1500/- per session.
2. The Resource persons in twin city Cuttack-Bhubaneswar will be paid ₹500/- who use their own conveyance as fixed travel allowance and those who come from outside the twin city Cuttack-Bhubaneswar will be paid as per the actual travel expenses (*limited maximum to 2-Tier Railway AC fare*) and ₹500/- for local conveyance.
3. The rate of Eminent Resource Persons invited for Workshop, Seminar, BPSPA Lecture Series will be ₹. 5000/- as Honorarium. BPSPA will provide free boarding and lodging facilities.
4. BPSPA, Bhubaneswar shall maintain feedback from trainees for guest faculties, including in house faculties, on a scale of 1 to 10. Selection / empanelment of faculties shall be done on the basis of such feedback.
5. This shall come into force from date of its issue.
