Sir,

I am directed to convey the sanction of Governor for creation of 438 new posts in various ranks for augmentation of manpower under Special Branch of Intelligence Directorate as indicated at **Annexure**, in the level of pay mentioned against each below and other allowances sanctioned by Government from time to time.

2. These posts are being created in lieu of immediate abolition of equal number of posts from Special Operations Group (SOG), Police Motor Transport (PMT) and 1st OSAP (SS) Battalion, Sambalpur as indicated below.

The base level posts meant for direct recruitment shall be filled up on contractual basis in terms of stipulations contained in erstwhile GA Department Notification No. 1147/Gen. dated 17-01-2014 and No. 32010/Gen. dated 12-11-2013 read with GA & PG Department Notification No. 28626/Gen. dated 27-10-2021 and 28621/Gen. dated 27-10-2021 respectively, following relevant recruitment rules and provisions of ORV Act.

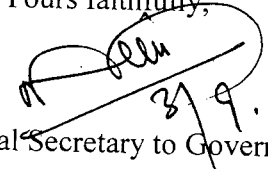
The promotional posts are to be filled up observing relevant Rules and ORV Act.

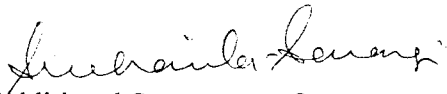

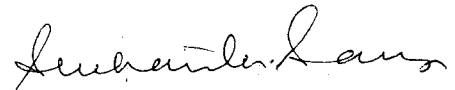
