ORDER

HOME-OSS-CASE1-0005-2017 37363 /OSS, Dated the 04 Nov', 2022

Whereas, Sri Chinmaya Behera, ASO, Higher Education Department was reverted to the post of Senior Grade Typist vide Home Department Office Order No. 23092/OSS dated 13.06.2017;

And whereas, Sri Behera obtained an order of stay from the learned Odisha Administrative Tribunal, Bhubaneswar vide their Order No. 03 dated 28.06.2017 in O.A. No. 878/2017 to continue in the post of ASO prior to his relief by the Department of Higher Education to enable him to join in the post of Senior Grade Typist,;


And whereas, the O.A. No. 878/2017 was transferred to the Hon'ble High Court and was renumbered as WPC (OA) No. 878/2017 after abolition of the learned Odisha Administrative Tribunal;

And whereas, Hon'ble High Court vide their Order dated 26.08.2022 passed in WPC(OA) No. 878/2017 disposed of the said writ petition with a liberty granted to the petitioner to approach the authority concerned if any cause of action still survives;

And whereas, an I.A. No. 357 of 2022 was further filed on 16.09.2022 by the petitioner for modification/recall of the order dated 26.08.2022 passed in this writ petition, the Hon'ble High Court vide their order dated 28.09.2022 has dismissed the I.A. with a view that the Court is not inclined to modify/recall the order dated 26.08.2022..

And whereas, after disposal of the WPC (OA) No. 878/2017 as well as dismissal of I.A. No. 357 of 2022, there exists no force of the stay granted vide Order dated 28.06.2017 in the abovementioned WPC (OA) No. 878/2017. Thereby Sri Chinmaya Behera is directed to join forthwith in the post of Senior Grade Typist as his services have already been placed under the Home (Common Cadre) Department for further posting upon his reversion vide the Home Department Office Order No. 23092 dated 13.06.2017 and Office Order No. 15944 dated 21.06.2017 of the Department of Higher Education.
