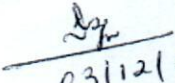
Whereas Sri Suresh Kumar Panda, Ex-Fire Officer was involved in Cuttack Vigilance P.S. Case No.06 dt.26.03.2001 u/s 13 (2) r/w 13(1) (e) P.C. Act, 1988.

2. And Whereas Sri Panda was convicted on 28.12.2012 by the Ld. Special Judge, Special Court, Cuttack in the aforesaid case for accumulating disproportionate property worth Rs.16,32,400.89/- and sentenced to undergo R.I. for a period of three years and to pay a fine of Rs. 16,00,000/-(Sixteen lakhs) only in default to undergo further R.I. for a period of one year.

3. And whereas Sri Panda had challenged the conviction order and sentence in appeal before the Hon'ble Orissa High Court in CRLA No.02/2013 and is subjudice.

4. And whereas, Government after careful consideration, taking into account conviction and sentence to R.I. of Sri Panda in Cuttack Vigilance P.S. Case No.06 dated 26.03.2001, has been pleased to withhold the Provisional Pension of Sri Suresh Kumar Panda, Ex-Fire Officer till finalization of the appeal, u/r 7 of the OCS (Pension) Rules, 1992.

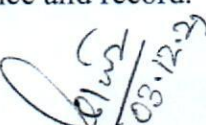

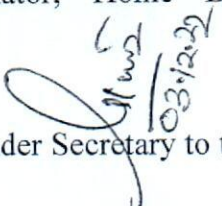
