HOME-SPS-PMTN-0006-2023- 25400 /SPS, Sri Surendra Nath Satapathy, OPS, is promoted retrospectively on ad-hoc basis to the grade of OPS Group-A (Senior Branch) i.e. to the rank of Additional Superintendent of Police of the O.P.S. The promotion of Sri Satapathy shall be subject to the final out come of the WP (C) No.35371/2022, WP (C) No.34769/2022, WP(C) No.36121/2022 & WP(C) No.30884/2022 pending before the Hon'ble High Court, Orissa.

The promotional posting of the officer in the grade of OPS (SB) shall be decided by the D.G. & I.G. of Police as per power delegated to him vide Home Department Notification No.18407/D&A dated 06/04/2007.
