The promotion of above officers shall be subject to the final out come of the WP(C) No.35371/2022, WP(C) No.34769/2022, WP(C) No.36121/2022 & WP(C) No.30884/2022 pending before the Hon'ble High Court, Orissa.

2. The posting orders of the above promoted officers except those on deputation, will be issued by the D.G. & I.G. of Police, Odisha, Cuttack under the powers delegated to him vide Home Department Notification No.18407/D&A dated 06/04/2007. The posting order of the Officers working on deputation may be issued only after their reversion to the parent cadre.

3. The Officers currently on deputation to other Department / Organization may revert back to their parent cadre to avail the promotion in case they are not provided the higher grade by the Department / Organizations they are working for. If they do not represent in writing, through proper channel, for their reversion they shall continue to work in their Departments / Organizations in the same grade and they shall have no claim to higher grade and pay till their reversion to parent cadre.
