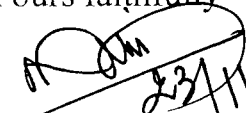
Sir,

In continuation to the above said letter the following addendums are hereby issued for smooth and efficient functioning of the Security Wing.

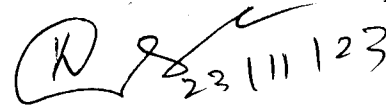

The existing sanctioned posts of Superintendent of Police Security Wing-1, Additional Superintendent of Police - 2, Deputy Superintendent of Police - 08, Inspector - 15, Sub-Inspector - 55, and Assistant Sub-Inspector - 23 created vide this Department's earlier letter no. 23203 dtd 5-5-2007 and no. 10621/D&A dtd 06-03-2019 in the Security Wing are to be borne in the corresponding equivalent armed cadre posts.
2. The posts of Deputy Commandant, Assistant Commandant, Inspector (Armed), Sub Inspector (Armed) , Assistant Sub Inspector (Armed) in Security Wing may be held by equivalent rank officers from other establishments of Odisha Police or even outside depending on suitability and availability of officers.

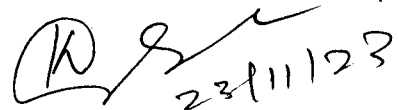

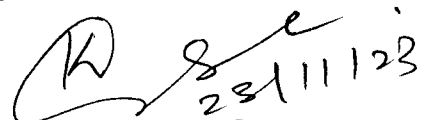
