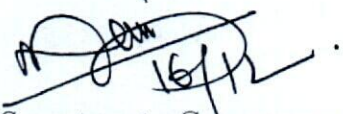
2. The afore-mentioned newly created posts shall be filled up in a transparent manner following relevant recruitment rules and provisions of ORV Act.

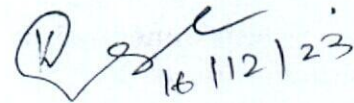

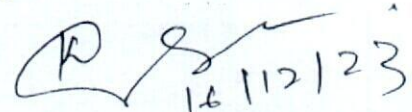

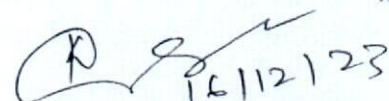
