**ORDER**

**Sub : Revision of prisoner feeding charges**

Proposal for enhancement of prisoners feeding charge for those interposed/detained in Police Custody under section 149/151 Cr. P.C. for those detained in Police Custody in specific criminal cases was under active consideration of Government for quite some time.

In partial modification of this Department's earlier letter no. 53193 dated 20-12-2006, Government has been pleased to enhance the prisoner feeding charges as follows :


- from ₹ 20 /- to ₹ 40 /- per meal for those interposed/detained in Police Custody under section 149/151 Cr. P.C. and
- from ₹ 30 /- to ₹ 50 /- per day for those detained in Police Custody in specific criminal cases.

2. This shall come into effect from the date of issue of this order.

3. This charge is debitable to appropriate Units of Administrative expenditure under Head 'Demand No. 1-MH- 2055 - Police - EOME - 001 - Direction & Administration - 0121 - Charges for Police Custody - 24013 - Expenditure towards Police Custody'.

4. This has been concurred in by Finance Department in their OSWAS file FIN-GS1-BT-0002-2024 read with FIN-CS2-ALW-0002-2024.






