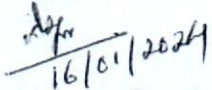
Sub-Divisional Police Office, Sadar and Sub-Divisional Police Office, Hindol shall supervise the work of Police Stations as indicated in the table below.

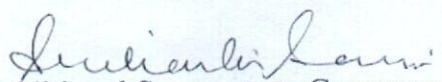

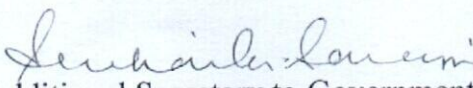

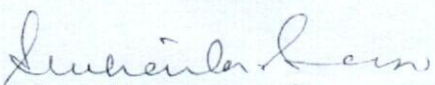
