2. In lieu of creation of aforementioned Special Security Battalion at Puri; 139 posts of A.P.R. Force created earlier under Singhdwar Police Station (*vide this Department's earlier letter no. 17367 dated 31-03-2008*) for safety and security of Shree Jagannath Temple, Puri are hereby abolished.

3. The said Special Security Battalion at Puri would function under the command and control of Superintendent of Police, Puri.

4. The aforesaid newly created posts shall be filled up by following relevant recruitment rules and provisions of ORV Act.

5. In principle approval is given for outsourcing of various services of Group D staff for the said Special Security Battalion.

6. The charge is debitable to the appropriate Units of Administrative Expenditure under Head 'Demand No. 1 - 2055 - 00 - Police- EOME - 104 - Special Police - 1327 - Special Police Organization'.
