WHEREAS, Smt B. Radhika, IPS,(RR-1989) at present Chairman, Police Recruitment Board, with the additional charge of Director, S.F.S.L, Odisha has applied vide her letter dated 31.12.2023 & 11.01.2024 for voluntary retirement from Government service under Rule.16(2) of AIS(DCRB)Rules,1958.

AND WHEREAS, sub-Rule (2) of Rule 16 of AIS (DCRB) Rule,1958 provides that a member of Service may after giving at least 3(three) months previous notice in writing to the State Government to retire from service on the date on which such member completes 30 (thirty) years of qualifying service or attains 50(fifty) years age or on any date thereafter.


AND WHEREAS, the date of birth and date of entry into Indian Police Service of Smt B. Radhika, IPS being 04.07.1964 and 21.08.1989 respectively, she has attained 50(fifty) years age and completed 30(thirty) years of qualifying service and Smt B.Radhika,IPS is eligible to retire from Government service voluntarily under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958.

AND WHEREAS, the State Government are empowered under Rule 16 (2) of AIS (DCRB) Rule, 1958 to accept the application for voluntary retirement of the IPS officers belonging to the State cadre concerned and as per second proviso to Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958, the State Government concerned on a request made by the member of service may relax the mandatory period of 3 (three) months previous notice.

AND WHEREAS, in exercise of the powers conferred on them under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958, the State Government have been pleased to relax the mandatory notice period of three months in case of Smt B. Radhika, IPS for her voluntary retirement from Government Service to take care of her parents.

NOW THEREFORE Smt B. Radhika, IPS at present Chairman, Police Recruitment Board, with the additional charge of Director, S.F.S.L, Odisha is allowed to retire voluntarily from the Indian Police Service under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958 w.e.f. 01.02.2024(F.N.), She will be entitled to all retirement benefits as per rule under AIS (DCRB) Rule,
