In inviting a reference to your letter No.464/OBS/2023/OPS dtd.28.11.2023 on the above noted subject, I am directed to say that at present there are only about 60 (sixty) IPS officers of the allotment year 1993 to 2015 available in Odisha and more than half of them are working as district SP, in Chief Minister's Office and in the field of Essential Services. Further, Simultaneous General Elections is also going to be held in Odisha during the year 2024. There is acute shortage of IPS officers for police administration of the state. Hence it is not possible to spare 20 IPS officers for police observer duty. In view of the above required information in Format "A" and Format "B" in respect of 8(eight) IPS officers and 5(five) OPS officers of Odisha cadre are enclosed herewith. Besides above Shri Radha Kishan Sharma, IPS, ADGP (Hdqrs), Odisha has been nominated as Nodal Officer and prescribed format containing required information about Shri Sharma, IPS is also enclosed herewith.
