Sub: Grant of Paid Holiday to employees on the day of Poll in connection with General Election to Lok Sabha, 2024 in the State of Chhattisgarh - regarding.

Madam/ Sir.

In inviting a reference to the subject cited above, I am directed to enclose herewith letter No.439. dt. 16.03.2024. received from Chief Electoral Officer, Chhattisgarh relating to grant of paid holiday to employees who are working in Odisha and entitled to vote at General Elections to Lok Sabha, 2024 in the State of Chhattisgarh on the day of Poll i.e. **19th April 2024 (Friday), 26th April, 2024 (Friday) and 7th May, 2024 (Tuesday)** as per Section 135B of the Representation of the people Act, 1951.

It is pertinent to mention here that Section 135B of the Representation of the people Act, 1951 provides for grant of paid holidays to the employees on the day of poll. The provisions under the said Section states that all employees of establishments and shops including those which work on shift basis shall be granted a paid holiday on the day of poll in the Constituency where an election is to be held. Further, there may be cases where a person is ordinarily a resident of the Constituency and registered as an elector, may be serving / employed in an industrial undertaking or an establishment located outside the constituency having an election. It is clarified that in such a situation, even those electors including casual workers working outside the constituency concerned, would be entitled to the benefit of a paid holiday extended under Section 135 B (1) of the Representation of the People Act, 1951.

This is for favour of kind information and necessary action.
