On being appointed as Assistant Section Officers, they are hereby posted to **Handlooms, Textiles and Handicrafts** Department.

They shall remain on probation for a period of two years from the date of joining in the service subject to fulfilment of the following conditions.

1. Their appointments are purely temporary and subject to verification of character and antecedents and can be terminated at any time without assigning any reason thereof.
2. The candidates are instructed to join in the Department within 30 days from the date of issue of this appointment order failing which their appointment shall be automatically cancelled.
