In pursuance of Odisha Secretariat Service (Method of Recruitment and Conditions of Service) Rules, 2016 and amendment thereto, the State Government do hereby appoint the following selected candidates as Assistant Section Officers in Odisha Secretariat Service (Group-B) out of the Select List furnished by OPSC vide their Memo No.9553 Dt. 30.12.2023 and Memo No. 500 Dt. 25.01.2024, in Cell-01, Level-09 (Rs. 35,400/- to 112400/-) of the Pay matrix under Odisha Revised Scale of Pay Rules, 2017 with usual D.A & other allowances as admissible to Government employees from time to time, from the date of his actual joining in the post. On being appointed as Assistant Section Officers, they are hereby posted to **General Administration (Vigilance)** Department.

They shall remain on probation for a period of two years from the date of joining in the service subject to fulfilment of the following conditions.

1. Their appointments are purely temporary and subject to verification of character and antecedents and can be terminated at any time without assigning any reason thereof.
2. The candidates are instructed to join in the Department within 30 days from the date of issue of this appointment order failing which their appointment shall be automatically cancelled.
