ORDER

No. HOME-OSS-MISC-0006-2024 19359 /OSS, dated 31.05.2024

On being selected and recommended by the OPSC, Sri Jitendra Muni was given temporary appointment in the post of Assistant Section Officer and was posted in General Administration and Public Grievance Department vide Home Department Order No.5357 Dt.08.02.2024. The appointment was subject to final outcome of SLP(C) No. 1302 of 2024 pending before the Hon'ble Supreme Court of India, verification of character and antecedents and the same can be terminated at any time without assigning any reason thereof. Sri Muni submitted his joining in G.A & P.G Department, but it has not yet been accepted as he intimated about the pending of different cases.

In the meantime the Character and Antecedent verification report of Sri Jitendra Muni has been received from the Collector and District Magistrate, Ganjam. It has been reported therein that Sri Muni is involved in Dharakote PS Case No.102 Dt.16.06.2021 U/s 498-A/341/323/294/313/506/34 IPC/4 DP Act, which is charge sheeted and pending for trial in the Court of JMFC, Aska.

Hence, in compliance to the provisions contained in the Resolution No-34438 Dt.20.11.1999 of the G.A & P.G Department and the advice of the G.A. and P.G. Department as well as keeping in view the stringent policy of Government against the dowry offence, the appointment of Sri Jitendra Muni in the post of Assistant Section Officer is hereby cancelled.

Home Department Order No. 5357/OSS Dt.08.02.2024 stands modified accordingly.
