Whereas Shri Nagaraj Devarakonda, IPS (WB:2018) made a representation dated 27.07.2023 to Government of India, MHA for his inter-cadre-transfer from West Bengal to Odisha on the grounds of his marriage with Ms. S Susree, IPS (OD:2018).

And whereas Government of India, MHA had requested the Government of Odisha to offer view / comments on the aforesaid request of the MoS.

And whereas after careful consideration of the case "No Objection" of Government of Odisha for inter-cadre transfer of the MoS from West Bengal to Odisha was conveyed to the Government of India, MHA.

And whereas, MoS had filed O.A. No. 3738 of 2023 before the Central Administrative Tribunal, Principal Bench, New Delhi being aggrieved on the action of the West Bengal Government on the matter of his inter-cadre transfer from West Bengal to Odisha Cadre.

And whereas Hon'ble, Central Administrative Tribunal, Principal Bench, New Delhi in O.A. No. 3738 of 2023 has passed order dated 29.05.2024 in favour of MoS for his inter cadre transfer from West Bengal to Odisha Cadre.

And whereas in compliance with the Order dated 29.05.2024 of Hon'ble Central Administrative Tribunal, New Delhi in the O.A. No. 3738 of 2023, the Government of India, Ministry of Home Affairs transferred the MoS from West Bengal cadre to Odisha Cadre on the ground of his marriage with Ms. S Susree, IPS.

And whereas, in compliance with above orders of Hon'ble CAT, Principal Bench, New Delhi the MoS joined before the Additional Chief Secretary to Government of Odisha, Home Department on 26.07.2024.

Now, therefore, the State Government after careful consideration of the above facts accepted the joining of Shri Nagaraj Devarakonda, IPS w.e.f. 26.07.2024 and he is posted as AIG of Police, Hdqrs. to undergo AET training.

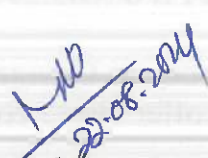

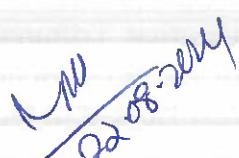
