Sir,

In inviting a reference to the subject cited above, I am directed to say that Government has been pleased to approve engagement of 07 Special Police Officers - SPOs (retired police personnel in the rank of ASI / SI / Inspector or equivalent ranks under Police / CAPF / Ex- Servicemen category) for implementation of Highway Patrolling on the identified stretch between Manguli Chhak to Pitapalli Chhak under Commissionerate Police, Bhubaneswar-Cuttack.

2. The engagement of these 07 SPOs is over and above 119 SPOs engaged earlier for Highway Patrolling on 5 identified stretches across the State.

3. The remuneration of these 07 SPOs shall be borne out of budget provision under 'Demand No.01-2055-Police-00-EOME-001-Direction & Administration-1712-Introduction of Commissionerate System in twin cities of Bhubaneswar-Cuttack- 01004-Salaries for Consolidated Pay Post'; as done earlier.

Further, their remuneration shall be guided by this Department's earlier letters bearing no. 55293/D&A dated 11-12-2019 and no. 11145/D&A dated 16-03-2021.

4. Moreover, 2 vehicles shall be hired for patrolling on said stretch wherein the cost of hiring of vehicles, fuel and purchase of equipment etc. is to be met from allotment released by Commerce & Transport (Transport) Department from Road Safety Fund; as done earlier.

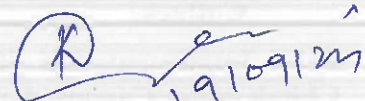
