In partial modification of this Department's earlier letter bearing no. 3702/D&A dated 31-01-2024 ; I am directed convey that

- a. The newly created Special Security Battalion at Puri is hereby renamed as 'Swatantra Shree Mandir Surakshya Vahini' (SSMSV) , Puri.
- b. Further, for sake of administrative convenience, there shall be no direct recruitment of Sepoys to SSMSV and same shall be filled up on deployment basis.
2. Moreover, sanction of Governor is hereby accorded for creation of 720 posts of Sepoys (Level 5 of Pay Matrix under ORSP Rules, 2017) in various Battalions across the State as indicated in the table below as deployment reserve for equal number of posts of Sepoys created vide this Department's earlier letter no. 3702/D&A dated 31-01-2024.
