WHEREAS, Shri Arun Kumar Sarangi, IPS (RR:1990) at present Special D.G of Police, Training & Director, BPSPA, Odisha has been appointed as Chairman, Odisha Public Service Commission vide G.A & P.G Department Notification dated 28840/Gen dated 27.09.2024.

AND WHEREAS, Shri Arun Kumar Sarangi, IPS has applied for voluntary retirement from the IPS w.e.f. 07.10.2024 FN vide his letter No.4241/BPSPA-Estt. dated 30.09.2024 to enable him to take up his new assignment.

AND WHEREAS, sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958 provides that a member of Service may after giving at least 3(three) months previous notice in writing to the State Government to retire from service on the date on which such member completes 30 (thirty) years of qualifying service or attains 50(fifty) years age or on any date thereafter to be specified in the notice.

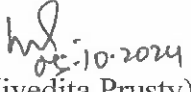
AND WHEREAS, the date of birth and date of entry into Indian Police Service of Shri Arun Kumar Sarangi, IPS being 25.07.1965 (25th July ,1965) and 15.09.1991 (15th September, 1991) respectively, Shri Sarangi, IPS has attained the age of 59 years and 33 years of qualifying service and Shri Arun Kumar Sarangi, IPS is eligible to retire from Government service voluntarily under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958.

AND WHEREAS, the State Government are empowered under Rule 16 (2) of AIS (DCRB) Rule, 1958 to accept the application for voluntary retirement of the IPS officers belonging to the State cadre concerned and as per second proviso to Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958 the State Government concerned, if satisfied and for reasons to be recorded in writing relax the mandatory period of 3 (three) months previous notice.

AND WHEREAS, in exercise of the powers conferred on them under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rule, 1958, the State Government have been pleased to condone the mandatory notice period of three months in case of Shri Arun Kumar Sarangi, IPS for his voluntary retirement from service.

NOW THEREFORE, Shri Arun Kumar Sarangi, IPS at present Special D.G of Police, Training & Director, BPSPA, Odisha is allowed to retire voluntarily from the Indian Police Service under Sub-Rule (2) of Rule 16 of AIS (DCRB) Rules, 1958 w.e.f. 07.10.2024 F.N. He will be entitled to all retirement benefits as per rule under AIS (DCRB) Rule, 1958.
